**APPLICATION RATE:** 2 oz. (by weight) per 100 lbs wheat seed. 1 measuring scoop, provided, treats approximately 60 lbs. wheat seed.

**DIRECTIONS FOR USE:** Apply as a dry seed treatment prior to planting.

**DRILL BOX APPLICATION:** Measure appropriate amount of SabrEx and sprinkle onto seed in the planter or drill box. For best results, fill planter box with seed, then add SabrEx and mix until uniform seed coverage is obtained.

**BULK APPLICATION:** Apply by manually or mechanically dispersing SabrEx into a flowing stream of seed. Ensure that SabrEx is evenly dispersed in the planter or drill box.

**COMPATIBILITY:** SabrEx for Wheat and Cereals PB is compatible with many common wheat seed fungicides and insecticides. For current compatibilities, contact your ABM representative or call 877-617-2461.

**CAUTION:** SabrEx may be used either on untreated seed, or seed that has been treated with a fungicide or insecticide. Wear appropriate protective gear, avoid skin contact or breathing of dust, and follow the caution statements of the other treatments if the seed has been pretreated. 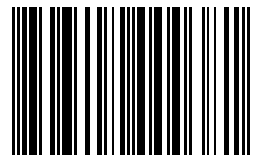
