Planter Box Formulation



APPLICATION RATE: 0.5 oz. (by weight) per 80,000 kernel bag of seed corn. One 80cc measuring scoop, included, holds approximately 1 oz. Sabrex PB and treats approximately 2 x 80,000 kernel bags of seed corn. Sabrex for Corn PB can be used for popcorn, sweet corn and sunflowers at a rate of 2 to 4 oz. per 100lb. of seed. Contact your ABM representative for details.

DIRECTIONS FOR USE: Apply as a dry seed treatment prior to planting.

PLANTER BOX APPLICATION: Measure appropriate amount of Sabrex and sprinkle onto seed in the planter box. It is best to treat in one bag (80,000 seeds) increments to insure uniform distribution of Sabrex on the seed. Mix until uniform seed coverage is obtained.

BULK APPLICATION: Apply manually or mechanically dispersing Sabrex into a flowing stream of seed. Ensure that Sabrex is evenly dispersed in the planter.

COMPATIBILITY: Sabrex for Corn PB is compatible with many common seed corn fungicides and insecticides. For current compatibilities, contact your ABM representative or call 877-617-2461.
