Soil has not hosted the specific legume for more than three (3) years • Soil pH is less than 5.8 (the pH should be adjusted by liming prior to inoculation) • Soil pH is more than 8.5 • Organic matter is less than 1.5 • Drought or flooding has occurred • Topsoil exceeds 80° F • Soil erosion • Use of soil treatments and chemicals injurious to soil bacteria and inoculants.

## IN-FURROW USE:

America's Best Inoculant must be emptied into spray tanks that have been cleaned and are free from all chemical residue. Dilute inoculant in clean, cool, NON-CHLORINATED WATER. Recommended rate of water per acre is 10 to 20 gallons.
