Application Rate: 8 fl. oz. (by volume) per 50 bags (80,000 kernel bag) of seed corn. This container treats 2,000 (80,000 bag) of seed corn, rate on seed 0.16 fl. oz. per 80k

Directions for Use:

1. Add first to the tank mix the desired quantity of **NON-CHLORINATED** water and liquid seed treatment products, if used.
2. **START TANK AGITATION AND MAINTAIN AGITATION AT ALL TIMES.**
3. Measure appropriate quantity of SabreX™ for Corn LQ and add slowly to the mix tank.
4. Be sure the liquid disperses completely into the slurry.
5. Apply to seed.

Compatibility:

SabreX™ for Corn LQ is compatible with many common seed corn fungicides and insecticides. For current compatibilities, contact your ABM representatives or call **877-617-2461**.

Tank Mix Restriction:

SabreX™ for Corn LQ can be left in the tank mix for a maximum of 4 hours; longer may result in loss of viability. IF THIS TIME IS EXCEEDED, DISCARD THE MATERIAL OR ADD MORE SABREX™ FOR CORN LQ.
